Minutes from Wednesday, December 10, 2025

Directors of McCurtain County Rural Water District No. 5, an Oklahoma corporation, held its regular monthly board meeting on December 10, 2025, at 4:00 pm at the water office located at 9180 N US Highway 259, Broken Bow, OK 74728.

1. Meeting was called to order and at 4:00 pm by Chairman, Kevin Perry.
2. Roll was called and quorum was declared. 4 Board Members present.

3. Recognition of guests. Howard Haggard, Dawn Hibben, Ray McElhaney.
4. Proof of Posting of meeting was provided by Kevin Perry, Chairman, with the meeting being filed with Secretary of State, McCurtain County Court House, and posted at the MCRWD#5 office/website see attachment.

5. Motion was made by Paul Sorensen and seconded by Kevin Perry to approve the consent agenda items A through F. Roll call Chuck Wilson- Yes, Kevin Perry- Yes and Tommy McDaniel- Yes. Motion carried.
6. Managers report was read by district manager Rodney Pratt.
Motion made by Paul Sorensen and seconded by Chuck Wilson to approve the managers report. Roll called Chuck Wilson- Yes, Paul Sorensen- Yes, Kevin Perry- Yes, Tommy McDaniel- Yes. Motion carried.
7. Comments from the public: Chuck Wilson introduced Dawn Hibben as a potential candidate to fill the open board seat. Dawn Hibben introduced herself and stated that she was a former executive director of Tarrant County Harvest in Fort Worth, where she worked with the city on hunger initiatives. She has past involvement with the Chamber of Commerce in Hugo, she has been in real estate for over 10 years in the Hochatown Area and has prior military service in the US Navy. She stated her resume is on linked in. Ms. Hibben expressed her interest in the position, citing her experience with community organizations and her desire to improve communications with residents. The board will consider this information and aims to hold a vote on filling the position at the January meeting.
